Hibernia Dam's rehabilitation includes a new rock filter toe, regrading of the downstream bench, and installation of a concrete cutoff wall in the auxiliary spillway. These structural repairs will increase the integrity of the dam and significantly lower any risks to public safety and health. Construction was completed in October 2020.
